8. Landscaping and trail reports, including approval of pay estimates, change orders, proposals for maintenance of landscaping and irrigation, and sidewalk construction.
9. Pond maintenance and mowing report.
10. Phase II Small MS4 General Permit and Storm Water Management Program including status of compliance, necessary training, and public comment.
11. Operation of District facilities, including billings, repairs, maintenance, and utility bill messages and amend Rate Order, if necessary.
12. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
13. Approve and authorize operator to file annual water loss audit.
14. Review Critical Load Spreadsheet for District's facilities and authorize annual filing.
15. Review Emergency Preparedness Plan and authorize filing of updates, if necessary.

 - b. phê Chuẩn Thông Báo và Văn Bản Bầu Cử.

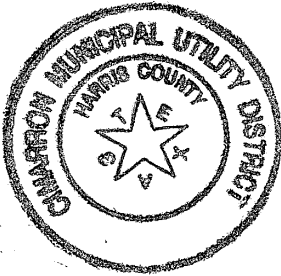
